*This Contract is subject to the terms and conditions set forth below.*

1. All prices are subject to change without notice at any time prior to signing of the bid sheet and receipt of deposit.
2. Any cancellation by purchaser of this purchase will entitle Nutrail Trailers to a cancellation fee of 25% of the contract price. Nutrail Trailers will not be required to refund the balance of any deposit made by the purchase until such time as Nutrail Trailers is able to see the unit contracted for by purchaser to an alternate purchaser.
3. Nutrail Trailers aims for a 90 day completion date from the time a contract is signed and deposit is received and/or an estimated lead time has been supplied to the purchaser for the construction of your trailer. However, due to potential supply chain limitations and manufacturing lead times via wait list Nutrail Trailers makes no guarantee or warranty as to the date of completion or delivery of the trailer contracted for in this agreement. In the event Nutrail Trailers has a wait list for completion of your trailer Nutrail Trailers will inform the purchaser of the lead times before completion of the contract. If the purchaser agrees to Nutrail Trailers current lead times Nutrail Trailers will supply an estimated start date for your unit. However, in the event your trailer build has not started beyond 60 days of the estimated lead time the purchaser may request and receive a full refund.
4. Purchaser Shall take possession of the unit contracted for within (15) days of being notified of its completion by Nutrail Trailers.
5. The balance of the purchase shall be due at time of completion, and before delivery or shipment. Personal Cheques are not suitable for final payment.
6. Purchaser shall be responsible for any and all fees charged to Nutrail Trailers as a result of payment by purchaser with Paypal or credit card. Alternate methods of payment can be arranged through Nutrail Trailers directly.
7. This agreement shall be interpreted and enforced in accordance with the laws of British Columbia, Canada.
8. In the event of a default in any of the terms of this Agreement, the prevailing party shall be entitled to all costs of enforcement of this Agreement, including reasonable attorneys' fees.
9. This agreement contains the entire understanding between the parties with respect to the subject matter of this agreement. There are no other agreements, understandings, representations or conditions, express or implied, oral or written, with regard to this agreement. This agreement may not be modified or amended other than by and agreement in writing.
